**Parent Involvement Program (PIP) - Volunteers Hours - Student Involvement Program (SIP)**

The **Parent Involvement Program (PIP)** requires a total of **40 hours** during the course of the academic year. Hours can be bought out in lieu of your volunteer time. PIP hours are \$40 each, except in the cases where you sign up for a specific assignment and are unable to fulfill your commitment and fail to either arrange for a suitable substitute or fail to notify the respective Mom & Dad's Club Chairperson, then you will be billed \$80 per each PIP hour you would have worked.

**The Polish Country Fair requires a minimum of 20 Hours and the St. Mary's Auction requires a minimum of 10 Hours per family.**

A) **20 hour** minimum requirement at the **Polish Country Fair** per family.

**Parent(s) must select (check) one of the following choices for Polish Country Fair hours:**

\_\_\_\_\_ I (we) will enroll in the PCF activities to fulfill the required 20 hours.

\_\_\_\_\_ I (we) elect not to participate at the PCF for the 20 hour PIP requirement and have enclosed a check for \$800 (per family).

B) **10 hour** minimum requirement at the **St Mary's Auction**. Hours can be fulfilled by volunteering time to help or by donating an acquisition item.

A \$40 acquisition item equals 1hr, or an acquisition item of \$400 or more would fulfill the 10hr minimum, maximum 20 hours.

C) **10 hours** additional for work at all other approved activities and school events.
